Coronial Services of New Zealand - Coroners Findings of Public Interest

A finding is a report written by the coroner about the facts of the death. The finding can also include comments or recommendations to help prevent similar deaths in the future. In order to publicise these lessons, the findings and recommendations are open to the public.

Medical Practitioners Disciplinary Tribunal – Commonly Cited Cases

The Medical Practitioners Disciplinary Tribunal heard and determined disciplinary proceedings brought against medical practitioners under Part VIII of the Medical Practitioners Act 1995 (the Act) up until the Health Practitioners Competence Assurance Act 2003 came into force in September 2004. From that date onwards the **Health Practitioners Disciplinary Tribunal** commenced this role for all health practitioners regulated under the HPCA Act 2003.
